#### **Shelf life**

The minimum shelf life of Post-it® Super Sticky Notes sold by 3M Office Supplies Division is two years from the date of manufacture.

To guarantee Shelf life, it is recommended that all Post-it® Super Sticky Notes be stored at optimum conditions (40-60% relative humidity and 15°C-26°C) when warehoused or on retail shelves.
